

TRY IT COLD Contest OFFICIAL CONTEST RULES NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. CONTEST PERIOD The "TRY IT COLD" Contest (the "Contest") begins at 12:00:00 PM Eastern Time on Tuesday, July 18th, 2017 and ends at 11:59:59 PM Eastern Time on Tuesday, August 1st, 2017 (the "Contest Period") and consists of one (1) entry periods as outlined below: Entry Period Start Date at 12:00:00 PM Eastern Time End Date at 11:59:59 PM Eastern Time Winner Announcement Date 1: August 2, 2017: Facebook LLC's servers are the official time-keeping device for this Contest.
- 2. ELIGIBILITY Access to a computer and Internet access are required. Participants must have a Facebook account and it must be public so that your posts are viewable to the sponsor and its agents. If you use a mobile device, message and data rates may apply. Please consult your wireless-service provider regarding its pricing plans. The Contest is open to legal residents of Canada and the United States who have reached the age of majority in their Province, Territory or State of residence as of the date of entry (the "Participants"). The public announcement of all winners will take place on the Winner Announcement Date, in a post on Tea Squared's Facebook account, tagging the winner's Facebook alias. Chances of winning depend on the total number of eligible entries received during the Contest Period.
